

GOVERNOR KOSTER ADMITS HELPED BY OMBUDSMAN SERVICE SUPERVISION

Denpasar (ANTARA) - Governor Bali Wayan Koster admitted being helped by Ombudsman supervision of public services in Bali.

"The regional government cannot do everything on its own, the ombudsman helps ensure public services run better, because we must support each other for the benefit of the community," Koster said in Denpasar, Friday.

Koster said, improving services to the community is not the responsibility of one institution alone, but rather requires support and collaboration from all government agencies.

The Bali Provincial Government itself is very helped by the existence of the ombudsman who carries out supervision functions over public services.

"The success of providing quality services will certainly give a positive image for the regional government, but the main role in supervision remains in the hands of the ombudsman so its existence must be strengthened," he said.

During a visit by the Chairman of the Ombudsman RI Rahmadi Indra Tektona and his team, Koster emphasized that all vertical government agencies in the center located in Bali fundamentally have the same goal, namely providing the best services to the community.

For that reason, the Bali Provincial Government is ready to provide support, including to the new central agency that has just been established.

"The regional government is an extension of the central government in the region, because of that, as long as for the benefit of public services, there must be mutual support," he said.

Through synergy that becomes increasingly tight between the Bali Provincial Government and the Ombudsman RI, it is hoped that the quality of public services in the island of Dewata will continue to improve so that the community can obtain services that are fast, transparent, accountable, and fair.

The Chairman of the Ombudsman RI Rahmadi Indra Tektona, as the leader of the delegation, then expressed appreciation for the support that has been given by the Bali Provincial Government.

According to him, synergy that has been established is hoped to become increasingly solid so that it can support the improvement of the quality of public services in various sectors.
